Businesses may join Canandaigua Country Club for the purpose of making the club house available for business meetings, client meetings, employment activities, and company social gatherings at a private country club setting on the lake away from distractions at the business site. Corporate members may reserve the club facilities for private business functions through the club's restaurant management staff. A Corporate membership establishes a direct billing channel from the club to the business relieving businesses of the task of reimbursing employees for business activities conducted at the club. The Corporate Membership fee is \$525 per club fiscal year and permits a business to identify up to four individuals that may sign for charges to the business. This membership is for business use exclusively. Corporate signers or other corporate employees may not use this membership for personal purposes unless they have their own personal membership to the club. All club activities under this membership category must be charged using the club charge billed directly to the business. There are no golf privileges associated with this membership class.
