

# Canandaigua Country Club

Policy Name: Honorary Golf Life Membership

## Introduction / Summary:

At times, a member may recommend to the Board of Directors that certain Canandaigua Country Club ("Club") members should be granted Honorary Golf Life Membership ("Honorary Membership") as recognition of their positive contribution towards golf and commitment to the Club.

## Minimum Criteria for Election to Honorary Golf Life Membership:

- Any person deemed by the Board to be deserving of the honor and elected to honorary membership by the Board of Directors
- Normally, a total combined age and senior golf membership years of 135.
- No longer a Club member in any golf classification
- Sponsorship by 2 Senior Golf Members in good standing
- Nominated Member must have participated in various Club activities, such as, but not limited to:
  - Been elected and served on the Board of Directors
  - Been elected and served as an officer of the Corporation
  - Participated on various official committees as recognized by the Board of Directors
  - Been an officer or Chairperson of the Women's Golf Association
  - Participated in various volunteer efforts for the betterment of the Club
  - Participated in Club leagues and events
  - Represented the Club in other organized tournaments in the area
  - Won Club Championship, Senior Club Championship, Super Senior Club Championship
  - Participated in other Club events such as social golf events, dinner events, etc.

## Rights and Privileges of Honorary Golf Life Membership:

- All rights and privileges of Senior Golf Members at no cost including
  - Golf
  - Dining privileges
  - Other Club activities
- Honorary Members will have to pay for
  - All food and beverage
  - Carts
  - Cart storage and trail fees
  - Tournaments
  - Social Events where membership is charged a participation fee
- All charges on account must be kept current. Past due balances will lead to cancellation of Honorary Membership
- Honorary Members will be exempt from
  - Minimum dining spending requirement (chits)
  - Special assessments

## Canandaigua Country Club

- Honorary Members will not be voting members of the Club nor will they be able to hold office
- If Honorary Member is a certificate holder at time of change of membership status, they will continue to hold membership rights in the Corporation's property

### Procedure:

- Nomination of member, in writing, to the President of the Board of Directors signed by two Active Senior Golf Members in good standing
  - Nomination should detail qualifications for consideration (as outlined above)
- All requests for Honorary Membership for the upcoming golf season must be submitted to the Board of Directors for consideration by the August Board of Directors meeting. Any follow-up questions will be assigned to a Board Member to resolve prior to the following meeting
- Board of Directors will vote on the nomination at the September Board of Directors meeting.
  - Approval will require a simple majority of the Board Members
- President of the Board of Directors will announce new honorary members at the Annual Meeting and communicate, in writing, the results of the Board's action to the nominee within 30 days
